

SOME USEFUL VERB PHRASE

What do you mean by Phrase?

A phrase is a collection or group of two or more words. A phrase is a part of a sentence and it can never be a complete sentence by itself.

For example: take care, break down, behind the wall, before the lunch, look after, etc.

What do you mean by Verb Phrase?

A group of words acting as a verb in a sentence, is called verb phrase. It is a unit which consists of an auxiliary(helping) verb and a main verb. However, it may consist just a single verb.

For example:

1. He was crying.
2. She came home in the evening.

There are two types of verb phrase:

- (a) **Finite Verb Phrase:** A verb phrase in which a finite verb acts as a head verb, is called finite verb phrase.

For example:

1. I love my mom.
2. I liked the dress.

- (b) **Non-Finite Verb Phrase:** A verb phrase in which infinitives, participles, or gerunds acts as a head verb, is called non-finite verb phrase.

For example:

1. I love to watch TV.
2. She is interested in cooking the meal.
3. Her favourite activity is playing with toys.
